SUBTERRANEAN CONTRACT and Limited Guarantee Agreement

AGREEMENT: For a period of one year effective 9/29/06 through 9/28/07,
PARADISE PEST CONTROL, INC. will provide necessary treatment for the control of subterranean termites for the
treated property for the sum of \$ 200.00 payable at time of service.

Any further treatment found necessary during the term of this plan, will be performed at no additional charge.

PARADISE PEST CONTROL, INC. will extend this limited guarantee annually to the Purchaser upon payment of an
annual renewal fee of \$ _____ for the second and third year, payable on or before the end of the
previous protection period. PARADISE PEST CONTROL, INC. reserves the right to adjust the annual renewal fee
after the third year and each year thereafter. The Purchaser will be notified in advance of any adjustment. This
Limited Guarantee may be extended upon payment of the annual renewal fee each year for an additional four
years.

This Limited Guarantee provides for treatment against subterranean termites (Reticulitermes sp., Heterotermes sp.),
this plan does not protect against formosan termites (Coptotermes sp.).

PARADISE PEST CONTROL, INC. must be notified prior to any additions or structural modifications to the treated
property. Failure to notify PARADISE PEST CONTROL, INC. shall void this Limited Guarantee Agreement.
Arrangements must be made with PARADISE PEST CONTROL, INC. for additional service at Purchaser's
expense. PARADISE PEST CONTROL, INC. reserves the right to adjust the annual renewal fee in the event of
such additions or structural modification.

The Purchaser understands that PARADISE PEST CONTROL, INC'S. liability under this Limited Guarantee is
limited to retreatment only, and does not guarantee against present or future damage to property or contents, nor
provides for repairs or compensation thereof.

Any additional provisions attached hereto, including the General Provisions on the reverse side and the inspection
graph dated 9/29/06 are part of this plan.
